

A Snapshot of Health Partnership's Milestones

1989 The problem of access to health care in Johnson County is identified by the United Community Services of Johnson County (UCS) and a report is published.

1990 The Johnson County Board of County Commissioners takes the lead and asks UCS to convene a task force on their behalf.

1991 Serving as a liaison, UCS explores funding potential and works together with the Johnson County Public Health Department, private practicing physicians and hospitals in Johnson County.

1992 **First Clinic:** Health Partnership of Johnson County is created and the first location opens at 8600 W. 95th St. in Overland Park, Kan. The "free" clinic provides limited adult acute and chronic disease care.



2000 **Olathe clinic:** Second site opens with medical services at 807 S. Clairborne Dr. in Olathe, Kan.

2002 Adds Dental services at the 807 S. Clairborne Dr. location and later expands to office space next door.



2008 Overland Park clinic relocates to 7171 W. 95th St., more than doubling its facility. Adopts a medical home model to expand clinic's services.



2011 Federally Qualified Health Center (FQHC) process begins.

2012 **Johnson County Clinic Consolidation:** All operations combine in a larger site at 407 S. Clairborne Dr., Olathe.



Receives FQHC designation. Begins Dental Outreach Program.

Paola clinic opens at 25955 W. 327th St. Olathe site receives Level III recognition as a Patient-Centered Medical Home. Pediatrics program begins.

2013 Launches Behavioral Health services.

2015 **Ottawa clinic** opens at 1418 S. Main St., inside the Franklin County Health Department. Establishes a mobile health clinic with Olathe Fire Department and Olathe Health. Partners with Kansas City University of Medicine and Biosciences to provide physician services. Paola clinic relocates to 1604 Industrial Park Dr. Initiates integrated medicine program.

2016 Acquires Pediatric practice. **Shawnee Mission clinic** opens at 9119 W. 74th St., Shawnee Mission, Kan.



2017 **Ottawa clinic** relocates to 107 S. Main Street and adds dental services. Integrates dental and primary care services for pediatric patients. Adds early-intervention substance abuse services.



2018 Launches School-Based Clinic at Merriam Park Elementary School-Shawnee Mission School District. Opens Pediatric Walk-In Clinic in Olathe for patients and community. Opens Adult Walk-In Clinic for people experiencing homelessness.

2019 Partners with Heartland Regional Alcohol and Drug Assessment Center to provide Substance Abuse Services to adolescents and adults.

Adds enrollment services for Food Assistance (SNAP) and temporary assistance for needy families and childcare.

Begins Patient Transportation Assistance program. Receives National Committee for Quality Assurance Distinction in Behavioral Health Integration.

Initiates Behavioral Health telehealth services to Shawnee Mission, Paola and Ottawa patients.

Welcomes pediatric practice patients from Wyandotte County. Offers same day appointments in Olathe to new or established adults and children.

2020 Provides Medication-Assisted Treatment (MAT) services for alcohol and opioid addicted persons. Responds to COVID-19 Pandemic with telemedicine visits and testing.

2021 Receives HRSA Health Center Program's Silver Quality Leader Award (ranked among the top 20 percent of health centers nationally for best overall clinical performance).



Continues to respond to COVID-19 Pandemic by offering first, second and booster vaccinations at HPC sites and community locations, such as schools.

Relocates School-Based Health Clinic to Shawnee Mission West High School in Overland Park, Kan.

Offers therapy services for youth and adults.

2022 30th Celebration

Continues to respond to COVID-19 Pandemic by offering home test kits, first, second and booster vaccinations and rapid and PCR testing as supplies allow.
